Nomination Process: Nominees can be self-nominated or nominated by someone else. Membership in Rotary not required.

Time Line: The nomination process is open now. Deadline to submit nominations are 5/1/2017. The award will be presented on 6/5/17 at the club's Monday lunch meeting held at Crown Plaza at Bell Tower Shops. Nominees and nominators are expected to attend and will be guests of the club. Please review the application before you fill it out. Although it is not necessary to provide all the details asked for, it is important to be explicit as to the nominee's achievements. Information provided in this application may be used in news coverage about the nominee. Additional pages may be used to complete the application. An anonymous Selection Committee will review the applications and select those to be honored. Application information will not be verified by the committee or the Rotary Club of Fort Myers South. As part of the 4 Way Test all statements and representations are considered to be above reproach.
